VEGETABLES

1. Entry forms shall be made at the Fair Office before 3:00 PM MONDAY, before Fair.
2. Entries must be brought to the Domestic Arts Building Saturday before Fair between the hours of 10:00 AM – Noon.
3. Entries may not be removed until Sunday, after Fair ends from 10:00 AM to 1:30 PM.
4. Exhibitors are to make only one entry in any class, except in classes where "any other vegetable" may be shown, in which case an individual may make not more than 3 entries in any one class, and those must be distinctly different and correctly labeled.
5. All exhibits must be clearly labeled.
6. All exhibits in the vegetable division shall be of excellent table quality and size in order to be eligible for premiums. Over large and mature specimens should not be exhibited, neither should immature specimens.
7. Onions should not be peeled but should be exhibited with their outer skins on them.
8. Any vegetables may be waxed to improve their appearance and keeping quality.
9. The Judge will reclassify any exhibits in the wrong class.
10. Juniors, 18 years and younger, must specify age on their entry card
11. All entries are to be on 8" or larger paper plates inside a zip-closure plastic bag.
12. Entries will be accepted from only those youth under the age of 18 who are not members of 4-H. All such youth entries must have been completed within the previous year. In no case will a prior 4-H entry be accepted as an open class entry. Residence in Allegany County is required of youth entries.
13. Juniors, 18 years and younger, must specify age on their entry form.
14. For Department 08 only residents of Allegany County or NYS adjoining Townships may enter in this department. Non-professional exhibitors ONLY. An exhibitor is considered a professional if he/she DOES use the sale of these (or similar) items as a major portion of his/her income. No exhibit may be offered for sale during the Fair. See list at end of Department 08 section for eligible townships.

08-301 Beans, Lima, 6 green pods containing edible beans. 08-302 Beans, snap, green, 10 pods

08-303 Beans, snap, yellow, 10 pods

08-304 Beans, snap, pole or vining type, 10 pods

08-305 Beans, green shell, 10 pods, any variety, i.e. Edible Soy, Horticultural, Kentucky Wonder

08-306 Beans, dry shelled, ½ cup in container, dry field bean variety, i.e. Mung, Adzuki, Fava

08-307 Beets, 3 specimens, tops trimmed to 1 inch

08-308 Broccoli, 1 head or bunch of small heads, 5 inches or more in diameter

08-309 Brussel Sprouts –1 pint basket

08-310 Cabbage, 1 head, 2 to 4 lbs., with 3 to 4 wrapper leaves, any fresh market variety.

08-311 Cabbage, 1 head, large size, with 3 to 4 wrapper leaves, any kraut variety 08-312

Carrots, 3, tops cut off to 1 inch, no green shoulders

08-313 Cauliflower, 1 head, leaves cut just above head

08-314 Celery, 1 plant, market quality, roots off

08-315 Chard, 1 plant, roots and damaged leaves off

08-316 Corn, sweet, 3 ears, husks removed completely, shank trimmed to ½ inch, display in transparent bag.

08-317 Cucumbers, 2 slicing types 4" or longer, 2" or less in diameter

- 08-318 Cucumbers, 5 pickling type, 3 to 5 inches long
- 08-319 Cucumbers, 10 pickling type, less than 3 inches long
- 08-320 Dill, bunch of 6 seed heads, tied or in transparent bag
- 08-321 Eggplant, 1, large oval, oblong types, i.e. Black Beauty, Ichiban, Long Tom, White Beauty.
- 08-322 Eggplant, 2 small, slender, round types, i.e. Easter Egg, Ichiban, Long Tom, White Beauty
- 08-323 Endive, 1 plant, roots off, good market size
- 08-324 Herbs, plant in pot or tied bunch
- 08-325 Kale, 1 plant, roots off
- 08-326 Kohlrabi, 2, tops and tap root trimmed to 2 inches
- 08-327 Leek, 3 large, trimmed
- 08-328 Lettuce, leaf, 1 plant, roots off, good market size
- 08-329 Lettuce, head, 1 plant, roots off, good market size
- 08-330 Muskmelon and honey dew melon, 1 good market quality
- 08-331 Mustard, 1 plant, roots off
- 08-332 Okra, 6, 1 ½ to 3 inches
- 08-333 Onions, 3, tops trimmed to ½ inch, well cured and dried, not peeled
- 08-334 Onions, 6, green bunching type, tops on but trimmed evenly
- 08-335 Parsley, 1 plant, roots off, good market size and quality
- 08-336 Parsnips, 3, tops trimmed to 1 inch
- 08-337 Peas, 10 pods
- 08-338 Peppers, 2 large, types such as Bell, Cubanelle, Italian Sweet
- 08-339 Peppers, 3, small types such as Banana, Hungarian Wax, Cherry, Jalapeno
- 08-340 Potatoes, 3 tubers, 5 to 10 ounces
- 08-341 Potatoes, 1 pint basket, salt potato types ¾ to 1 ¼ inch diameter
- 08-342 Pumpkin, 1, ripe, any pie variety
- 08-343 Pumpkin, 1, ripe and field variety
- 08-344 Pumpkin, 1, ripe, hard, ribbed stem, largest by dimensions in each exhibit period
- 08-345 Radish, 1 pint basket, tops trimmed to ½ inch
- 08-346 Rhubarb, 6 stalks, tops trimmed
- 08-347 Rutabagas, 1, top leaves trimmed off
- 08-348 Shallot, 3, tops trimmed to ¼ inch, dried, not peeled
- 08-349 Spinach, common, ½ pound in transparent bag
- 08-350 Spinach, New Zealand, ½ lb., bunch of tender tips 3-6 inch long, tied or in bag
- 08-351 Squash, summer, 2, young, skin tender, such as Zucchini, Yellow, Scallop
- 08-352 Squash, winter, 1, any large types such as Hubbard, Delicious, Banana
- 08-353 Squash, winter, 2, i.e. Buttercup, Butternut, Spaghetti, Table Queen, Golden Nugget
- 08-354 Squash, 1, round stem, largest by dimensions in exhibit period, i.e. Big Max, Big Moon, Mammoth
- 08-355 Sweet Potatoes, 3 roots, any variety
- 08-356 Tomatoes, 3 ripe, stems off, medium & large fruited variety, including Roma Types
- 08-357 Tomatoes, cherry, ripe, 1 pint basket, stems off, also Presto and small fruited types
- 08-358 Turnips, 3, tops trimmed to 1 inch.
- 08-359 Watermelon, 1, mature, market size
- 08-360 Miniature Vegetables, 6 of one type, harvested at small or baby stage
- 08-361 Ornamental Vegetables, 3, such as miniature pumpkins, gourds, decorative corn
- 08-362 Miscellaneous, any other vegetable or class not listed, display same number of specimens as similar crop
